

## Schumpeter School Award

June 11 & 12, 2015

In 2011 the Schumpeter School of Business and Economics and the Schumpeter School Foundation established the Schumpeter School Award for Business and Economic Analysis. The Schumpeter School Award underlines the importance of the work of Joseph A. Schumpeter, supports and stimulates Schumpeterian research, and aims to communicate this research among scholars and practitioners.

Although Schumpeterian research is primarily associated with Schumpeter's seminal contributions to the fields of innovation and entrepreneurship, Schumpeterian research covers many more research areas and has dispersed across a broad spectrum of academic disciplines, such as economics, business administration, political science, and sociology.

The Schumpeter School Award for Business and Economic Analysis is awarded for significant scientific contributions to Schumpeterian research. The Award is given to scholars who conducted theoretical or empirical research of outstanding quality and importance.
